### 1. Eligibility Criteria

### **Distinguished Fellow**

Nominees for the Distinguished Fellow Award will

- Be a graduate of Signature or Rising Leadership Program
- Have graduated 4 years or more ago
- Demonstrate outstanding and enduring contribution to WA community
- Be actively engaged with Leadership WA as one of our Alumni
- Support Leadership WA's vision of 'Courageous leadership shaping a better WA'
- Support Leadership WA's purpose to 'Create experiences and enduring connections which empower leadership action for meaningful impact'

Nominees are not required to be a Financial Alumni Member of Leadership WA. Alumni can nominate themselves for the Distinguished Alumni Award.

#### Honorary Fellow Award

Nominees for the Honorary Fellow Award will

- Be a leader in Western Australia
- Have made a significant and enduring contribution to Leadership WA
- Support Leadership WA's vision of 'Courageous leadership shaping a better WA'
- Support Leadership WA's purpose to 'Create experiences and enduring connections which empower leadership action for meaningful impact'

## 2. Terms & Conditions

- Nominations must be submitted and received by the specified date.
- The decision of Leadership WA, as the judging panel, is final and no correspondence will be entered into.
- Leadership WA has the right to disregard any incomplete entries or entries that do not comply with the Eligibility Criteria and Terms and Conditions.

- Changes cannot be made to any submitted applications.
- Leadership WA reserves the right to vet and substantiate information contained in entry applications and conduct any due diligence as required.
- All entry submissions are the property of Leadership WA and no feedback on individual submissions will be given unless requested in writing to ceo@leadershipwa.org.au.
- Leadership WA reserves the right to change the Award ceremony or other aspects of the process.
- The assessment, conduct and results of the Awards will not create any legal obligations between entrants and Leadership WA.
- Submission of an entry form indicates acceptance of the Leadership WA Awards Terms and Conditions.
